Visa Notes

- Passport: Original Passport with a validity of more than six months and minimum two blank pages for visa stamp.
 - a) Attach all your old passports (if any)
 - b) Photocopy of bio data pages of passport
- **Kyrgyztan Visa Application Form** : Two visa application form to be duly filled and signed by the applicant.(Photocopy can be used)
- Photo Specification: Two recent passport sized colored photographs on light background with 80% face cover on a matt or semi-matt finished paper (35mm x 45mm).

Please note: Photograph should not be more than 3 months old, scanned/stapled and should not be used in any of the previous visas.

Covering-Letter: Covering Letter from applicant on business letter head mentioning name, designation, passport number, purpose and duration of visit in brief. The letter should be duly signed by authorized signatory with company stamp and addressed to

 The Visa Officer, Embassy of the Kyrgyz Republic, New Delhi.

- Financials: Foreign Exchange endorsement / Copy of Credit cards
- Ticket: Confirmed return Air ticket
- Proof of Accommodation : Hotel confirmation
- Please Note: Visa fee depends on the Approval.
- Note:

a) For individual tourist staying in Kyrgyzstan up to one month it is necessary to submit letter from travel agency stating the dates of arrival and departure, contact organization or private host and the place of staying in Kyrgyzstan, approved by the Department of Consular Services, Ministry of Foreign Affairs of the Kyrgyz Republic (contact your partner/host in Kyrgyzstan).

b) For group tourists it is necessary to submit a letter from travel agency, indicating the exact dates of arrival and departure, contact information of tourist agency/travel agency from Kyrgyzstan. The full list of tourist group is also required. All the letters should by approved by the Department of Consular Services, Ministry of Foreign Affairs of the Kyrgyz Republic is required (contact your partner/host in Kyrgyzstan).

- For all type of visas within the duration more than one month and more than singleentry the visa support from the Department of Consular Services, Ministry of Foreign Affairs of the Kyrgyz Republic is strictly required (contact your partner in Kyrgyzstan).
- Important Note Applicants are advised to check the below link to know whether Yellow Fever Certificate is required or not. Vaccination requirements and recommendations for International Travelers.

Health regulation for passengers leaving India:- There is no health check requirement by Indian Government on passengers leaving India. However, persons leaving for a yellow fever infected area are advised in their own interest to get themselves vaccinated and to be possession of valid yellow fever vaccination certificates before they leave the country.
